Instructions to Captains/Managers

Clubs registering must meet the club eligibility criteria outlined in the *Nova Scotia Lifesaving Series Competition Manual*. All competitors must meet competitor eligibility criteria outlined in the *Nova Scotia Lifesaving Series Competition Manual*. Please refer to the *Nova Scotia Lifesaving Series Competition Manual* for further clarification.

Please Note the following:

1. The Team Registration Form (page 1 & 2) for clubs must be submitted to the Nova Scotia Lifesaving Series Commissioner by December 1, 2006.
2. The club competitor roster forms (page 3 & 4) must be submitted to the Nova Scotia Lifesaving Series Commissioner by December 6, 2006.

Please review the following instructions prior to filling out this form. For clarification on eligibility requirements, please refer to the *Nova Scotia Lifesaving Series Competition Manual*.

1. Clubs registering must supply the Nova Scotia Lifesaving Series with a full competitors list (Page 3 & 4), which must be approved by the NS Lifesaving Series Commissioner before the club will be permitted to compete.
2. Club Captains/Managers must provide a photocopy of each competitor's highest current Lifesaving Society award (minimum Bronze Medallion).
3. League registration fees are **\$15 per competitor** for all competitors. Registration fees covers the cost of competing only. It does not include the cost of banquets, caps, or event t-shirts. Please make cheques payable to *Nova Scotia Lifeguard Service*. Please refer to the *Nova Scotia*

4. Each Club must pay a Fee of \$20.00 per Round for each round that their Club competes
5. All competitors registering with a club must complete Individual Registration Form that includes a waiver (next page) and abide by the code of conduct as outlined in the *Nova Scotia Lifesaving Series Competition Manual*.

Waiver (all competitors must read before signing the Individual Registration form)

As a condition of entering, all competitors must realize that contests on this competition circuit are both physically and mentally demanding. By signing their name in the Waiver/Code of Conduct box above, all competitors, in consideration of their individual and club entry acceptance, hereby, on behalf of themselves, their heirs, executors and administrators, waive and release any and all rights and claims to damages they may have against the event organizers, their representatives, sponsors, successors and assigns, for any and all injuries that they may suffer as a result of this event.

Please read carefully before signing

- Conduct**
I agree to abide by the rules, regulations and code of conduct of the Lifesaving Series, and further to behave in a manner consistent with ideals of good sportsmanship.
- Voluntary Assumption of Risk**
As a competitor in a lifeguard competition, I recognize that there are certain risks inherent in the activity as a result of factors including but not limited to, stress, number of people, water temperature and conditions. I have prepared myself for the competition and know of no factor or condition which should be disclosed to the organizers or which would make it unsafe for me to compete. I voluntarily assume all risks, both physical and legal including but not restricted to, loss of damage to property, and personal injury including permanent disability or death.
- Waiver of Liability**
As a condition of entry and in consideration of my application as an individual or as part of a team being accepted, I hereby waive my right to make any claim, whether for negligence or otherwise against the Lifesaving Society, the host, the facility operator, owner or occupier, the sponsors, the organizing committee or any of the servants, agents, affiliates, volunteers, judges, officials or other persons involved in the organization or running of the competition, events or associated activities. I further agree to indemnify and hold harmless all of the above, from any claim made on my behalf or as a result of injury to my person or property.
- Model Release**
I transfer to the Lifesaving Society all rights whatsoever which I have in photographs and/or videos which photographers may have taken. I consent to the use of the photographs/videos for all purposes whatsoever, including without limitation, television, publications, and any trade or advertising purposes.
